c. Maximum pressure attainable at full flow, usually the unload pressure setting for load/no load control or the maximum pressure attainable before capacity control begins. May require additional power.

d. Total package input power at other than reported operating points will vary with control strategy.

NOTE: The terms "power" and "energy" are synonymous for purposes of this document.
